The May 26, 2020 meeting of the Connecticut Fire Chiefs was held via a ZOOM meeting on line.

Meeting was called to order at 19:05 by President Dixon.

A motion was made and passed to accept the secretary's report.

A motion was made and passed to accept the treasurer's report.

Committee reports: Keven Cooney reported from the new combined New England Fire Chiefs association. He will step down and let Pete Starkel taken over.

Chuck Flynn reported that the annual meeting is being postponed again, the executive board will meet on line. From the Volunteer and Combined section of the International, the annual conference is still planed for August 2020. If anything changes come about, he will let us know. The Symposium in the Sun is still being held in November, Chief Flynn will also let us know if anything changes.

Ted Schroll reported on legislation noting that there has been no change since our last meeting, he did go into the capitol but it was like a ghost town.
